and policy think-tank. The New Zealand Initiative. Nicola was a senior advisor to Prime Minister Rt Hon. John Key during his first term in government, and prior to that, a researcher for Rt Hon. Bill English. She lives in Wellington with her husband, Duncan and their four children.

Hon Mark Mitchell

Mark Mitchell is the Minister of Corrections,
Minister for Emergency Management and
Recovery, Minister for Ethnic Communities,
Minister of Police, and Minister for Sport and
Recreation. He is the Member of Parliament
for Whangaparaoa. In 1989, Mark joined the
New Zealand Police and was a member of the Dog Section
and Armed Offender's Squad. After leaving the Police, Mark
relocated overseas and launched an international business

career, including the start-up of his own security company.

Hon Chris Penk

Chris Penk is the Minister for Building and
Construction, Minister for Land Information,
Minister for Small Business and Manufacturing,
Minister for Veterans, Associate Minister of
Defence, and Associate Minister of Immigration.
He is also the local Member of Parliament for
the Kaipara ki Mahurangi electorate in Auckland's
rural north and northwest.
