Response to your Official Information Act request

Thank you for your email of 12 March 2025 to the Ministry for Ethnic Communities (the Ministry) requesting the following information under the Official Information Act 1982 (the Act):

Copies of any feedback the department provided the Ministry of Justice regarding amendments to the Crime Act related to citizen's arrest powers and extending powers for security guards since November 2024 to date

In response to your request, two documents have been found within scope and are summarized in the document schedule below. They are being released to you with certain information within one of the documents withheld under section 9(2)(a) of the Act to protect the privacy of natural persons.

As is required by section 9(1) of the OIA, I have considered whether the grounds for withholding information under section 9 of the OIA are outweighed by other considerations which would make it desirable, in the public interest, to make that information available. In this instance, I do not consider that to be the case.

Thank you for the opportunity to provide feedback on the draft Cabinet paper *Amendments to arrest and defence of property provisions in the Crimes Act*.

We believe the proposed changes to the Crimes Act could benefit ethnic businesses, such as dairy owners, who are affected by crime.

To maximise the benefits of these changes, we recommend that the Ministry of Justice ensures the changes to the Crimes Act are made accessible to ethnic businesses.

This could include translating key information about the changes into different languages.

The Ministry has developed guidance, [Unlocking Language Barriers](#), to support agencies in disseminating information and communicating with Culturally and Linguistically Diverse (CALD) communities. The guidance includes information to help agencies choose which languages they may want to make their information available in.
